The 2018 wage bracket withholding tables and the previously-released percentage method withholding tables are included in Publication 15. The 2018 withholding tax tables incorporate changes to the individual tax rates made by the TCJA. Employers should implement the 2018 withholding tables as soon as possible, but no later than Feb. 15, 2018. The 2017 withholding tables should continue to be used until the 2018 withholding tables are implemented.
